### Procedura pentru implementarea măsurii "Granturi pentru investiții acordate IMM-urilor"

În Monitorul Oficial nr. 1163 din data de 9 decembrie 2020 a fost publicat Ordinul nr. 3396/2020 pentru aprobarea procedurii de implementare a măsurii "Granturi pentru investiții acordate IMM-urilor" din cadrul schemei de ajutor de stat instituite prin OUG nr. 130/2020.

Condițiile, procedurile și mecanismul decontărilor sunt stabilite în cadrul sprijinului financiar acordat din fonduri externe nerambursabile. Granturile pentru investiții se acordă pe proiect și beneficiar și au o valoare cuprinsă între €50.000 și €200.000.

Măsura este valabilă până la 30 iunie 2021, iar plățile vor fi efectuate până la 31 decembrie 2023.

Înscrierile în cadrul programului și înregistrarea documentelor se efectuează online. Termenul de înscriere este până la data de 29 ianuarie 2021 (ora 20.00).

## Procedure to implement the "Investments grants for SMEs" measure

Order no. 3396/2020 for the approval of the procedure to implement "Investments grants for SMEs" within the state aid program as established by GEO no. 130/2020 was published in the Official Gazette no. 1163 on 9 December 2020.

The conditions, procedures, and payment mechanism are established in respect of the non-reimbursable grants. The grants are awarded per project and beneficiary and are between €50,000 and €200,000.

The measure is running until 30 June 2021 and the payments will be performed until 31 December 2023.

Registration and documents can be submitted online. The registration deadline for the measure is 29 January 2021 (8 pm).
