

Noutăți privind la Rabla pentru electrocasnice

În Monitorul Oficial nr. 958 a fost publicat Ordinul privind modificarea și completarea Ghidului de finanțare a Programului național de înlocuire a echipamentelor electrice și electronice uzate cu unele mai performante din punct de vedere energetic, aprobat prin Ordinul nr. 2.089/2020.

Printre principalele noutăți menționăm:

- Comerciantul înscris în Programul național de înlocuire a echipamentelor electrice și
 electronice (EEE) este obligat să predea cu titlu gratuit cantitățile de EEE uzate colectate prin
 intermediul Programului.
- Astfel, comerciantul are obligația să completeze o declarație pe propria răspundere cu privire la predarea cu titlu gratuit a EEE uzate către colectorul de deșeuri.
- Declarația pe propria răspundere trebuie încărcată în aplicația informatică a Programului "Rabla pentru electrocasnice", alături de celelalte documente necesare pentru obținerea finanțării nerambursabile.

News regarding "Rabla" Program for household appliances

Order for amending and supplementing of the Financing Guide of the National Program for the replacement of used electrical and electronic equipment with more energy-efficient ones was published on the Official Gazette no. 958.

Through the main changes we mention:

- The trader enrolled in the National Program for the replacement of used electrical and electronic equipment (EEE) is compelled to hand over the quantities of used EEE collected through the Program free of charge.
- Thus, the trader has the obligation to complete a declaration on his own responsibility regarding the free handing over of used EEE to the waste collector.
- The declaration on one's own responsibility must be uploaded in the on-line application of the "Scrap for household appliances" Program, together with the other necessary documents for obtaining non-reimbursable financing.
