

Noutăți privind Certificatul de atestare privind obligațiile la Fondul pentru mediu

În Monitorul Oficial nr. 1167 a fost publicat Ordinul privind modificarea Ordinului nr. 594/2006 pentru aprobarea Certificatului de atestare privind obligațiile la Fondul pentru mediu.

Printre principalele noutăți privind Certificatul de atestare privind obligațiile la Fondul pentru mediu menționăm:

- se solicită și se obține exclusiv în format electronic prin intermediul serviciului "Depunere declarații on-line" existent pe site-ul Administrației Fondului pentru Mediu (AFM), www.afm.ro.
 Astfel, toți contribuabilii trebuie să se înregistreze on-line la AFM pentru a putea obține acest Certificat.
- termenul de obținere a Certificatului este de 5 zile lucrătoare.
- certificatul eliberat şi comunicat online este valabil fără semnătura persoanelor împuternicite ale
 AFM, precum şi fără ştampila instituţiei.

News regarding Certificate of attestation of the obligations to the Environmental Fund

Order for amending of the Order no. 594/2006 for the approval of the Certificate of attestation of the obligations to the Environmental Fund was published on the Official Gazette no. 1167.

Through the main changes related to the Certificate of attestation of the obligations to the Environmental Fund, we mention:

- is requested and issued exclusively in electronic format through the "Online Declaration Submission" service available on the Environmental Fund Administration (EFA) website, www.afm.ro. Thus, all taxpayers must register online at EFA in order to obtain such Certificate.
- the Certificate can be obtained in 5 working days.
- the certificate issued and communicated online is valid without the signature of the authorized persons of EFA, as well as without the stamp of the institution.
