News regarding the deposit-returning system (DRS)

Decision for amending and supplementing GD no. 1,074 / 2021 on the establishment of the deposit-returning system for non-reusable primary packaging was published on Official Gazette no 116.

Among the main changes, we mention:

- The DRS Administrator is constituted in the form of a joint stock company. The Romanian state, represented by the Ministry of Environment, holds 20% of the shares, and the remaining 80% of the shares are owned by producers and traders who introduce and sell products in non-reusable primary packaging.
- Producers hold 75% of the company's shares and traders hold a maximum of 25% of the company's shares.
- The application for the appointment of the DRS Administrator must be submitted until 4 March 2022.

Noutăți privind sistemul de garanție-returnare (SGR)

În Monitorul Oficial nr. 116 a fost publicată Hotărârea pentru modificarea și completarea HG nr. 1.074/2021 privind stabilirea sistemului de garanție-returnare pentru ambalaje primare nereutilizabile

Printre principalele modificări menționăm:

- Administratorul SGR este constituit sub forma unei societăți pe acțiuni. Statul român, reprezentat de către Ministerul Mediului, deține 20% din acțiuni, iar restul de 80% din acțiuni sunt deținute de către producători și comercianți care introduc și comercializează produse în ambalaje primare nereutilizabile.

- Producătorii dețin 75% din acțiunile societății, iar comercianții dețin maxim 25% din acțiunile societății.
- Cererea pentru desemnarea Administratorului SGR se depune până la data de 4 martie 2022.
