# Payroll Newsletter June 2022

### 1.1 Modificarea valorii tichetului de masa

Conform Legii nr. 187/2022 pentru modificarea și completarea Legii nr. 165/2018 privind acordarea biletelor de valoare, începând cu data de 01 Iulie 2022, tichetul de masă va avea o valoare maximă de 30 de lei (majorata de la 20.17 lei, cât a fost până la 30 Iunie 2022).

# 1.2 Măsuri de sprijin în contextul SARS-CoV-2

În data de 20 Iunie 2022 a fost aprobat și publicat modelul declaraţiei pe propria răspundere pentru companiile care solicită măsuri de sprijin în contextul situaţiei epidemiologice determinate de răspândirea SARS-CoV-2.

Măsurile se referă la cei care înregistrează scăderi ale producţiei de cel puţin 10% faţă de aceeași perioadă a anului 2019, la fel ca și în cazul celor care înregistrează scăderi ale cifrei de afaceri, cu cel puţin 10% faţă de luna similară sau faţă de media lunară a cifrei de afaceri din 2019.

Companiile pot solicita în continuare ajutorul de la stat, până la data de 31 Decembrie 2022, conform Ordonanței de Urgență nr 73/2022.

#### 1.1 Amendments to the Pension Law

According to Law no. 187/2022 for the amendment and completion of Law no. 165/2018 regarding the granting of meal tickets, starting with July 1, 2022, the maximum value of a meal voucher is of RON 30 (increased from RON 20,17, as it was until June 30, 2022).

## 1.2 Support measures in the context of SARS-CoV-2

On June 20, 2022, the template of the statement to be submitted by the companies requesting support measures in the context of the epidemiological situation caused by the spread of the SARS-CoV-2 was approved and published.

The measures are applicable to those who register decreases in the production of at least 10% compared to the same period of 2019, as well as in the case of those who register decreases in turnover by at least 10% compared to the same month or compared to the monthly average in 2019.

The companies can still request the state aid, until December 31, 2022, according to the provisions of the Emergency Ordinance no. 73/2022.
