## Amendment the nominal value of meal vouchers

Ordinance no. 69/2023, modifying the value of the meal vouchers, was published in the Official Gazette no. 691/27.07.2023

### Main changes:

The increase of the meal vouchers' nominal value is performed in stages, as follows:

- From RON 30 to RON 35 starting with the 1<sup>st</sup> of August 2023;
- From RON 35 to RON 40 starting from the 1<sup>st</sup> of January 2024. Although the maximum nominal value of the meal vouchers should be indexed biannually, the limit of RON 40 will also be applied in August and September 2024.

Date of entering into force: 27<sup>th</sup> of July 2023

## Modificarea valorii tichetelor de masă

În Monitorul Oficial nr. 691/ 27.07.2023 a fost publicată Ordonanța nr. 69/2023 prin care se modifică valoarea tichetelor de masă.

### Principalele schimbări:

Majorarea tichetelor de masă se efectuează etapizat, după cum urmează:

- De la 30 de lei la 35 de lei începând cu 1 august 2023;
- De la 35 de lei la 40 de lei începând cu 1 ianuarie 2024. Deși, valoarea nominală maximă a biletelor de valoare se indexează semestrial, limita de 40 de lei se va aplica și în lunile august și septembrie 2024.

**Data intrării în vigoare: 27 iulie 2023**
